



## **SCHOOL FEES AND CHARGES**

### **EFFECTIVE TERM II 2025**

The following rates and figures apply to all learners at Woodford School Lusaka effective Term II 2025. These Fees are subject to review by the Board of Directors. This is normally done on an annual basis, but the Board reserves the right to adjust fees more frequently if necessary.

#### **SCHOOL POLICY ON PAYMENTS**

- Woodford School Lusaka operates a cycle of three terms a year, and tuition fees for a particular term are due and on the last day of the previous term or as otherwise invoiced.
